<p>General Comments</p> <p>A renewal inspection occurred today.</p> <p>Licensing observed flexible areas that are rich in opportunities for sensory learning, social interaction, language, exploration, manipulation, and representation. They are purposely designed and planned to enhance children's healthy development and learning. Educators accommodate children's emerging interests by making children's contributions and thinking visible through displays, documentation, photos and artwork.</p> <p>Bentleys room were outside when licensing staff arrived. As the children came in, they washed hands and sat down for snack. During the transition educator sang songs and engaged in conversations with the children. Educators and administrative staff sat alongside the children as they were eating discussing what everyone had for lunch and if they liked turkey. Educators sang songs, read stories and engaged in play with children.</p> <p>Adams room washed hands and sat down for snack when they arrived. Children had the freedom to move freely</p>
