Bentley's Room: The children were observed coloring, playing with dolls, dressing up in the dramatic play area, and building tracks to drive cars on. The educators were observed engaging in play with the children, down at the children's level when speaking or listening to the children and taking the lead of the children.

General Comments

The children were observed washing hands before and after snack. The educators were observed sitting and eating alongside the children engaging in conversations.

Adam's Room:

The children were observed applying sunscreen before heading outside to play. The children were observed playing on the climbing structure and searching for caterpillars, spiders, and snails. The educator was observed engaging in conversations with the children.

A discussion about purposeful planning was had with the Operator regarding the school age children. Bins of materials were evident in the outside shed but were not offered to the children. The Operator is to ensure toys and materials are brought out with the educator when playing on the back playground.

The following records were reviewed: Incident logs, fire drills, and daily attendance sheets.

All staff files were viewed, and a random review of the children files was completed.

The Inspector discussed Professional Learning hours with the Operator. The Operator has created duetangs with Professional Learning for the staff who do not have the required 10 hours. Once the 10 hours is completed the Operator is to send the updated tracking sheets to the inspector.
