*Postings - I know this information was up on my last visit, but please ensure the above information is posted at all times upstairs and downstairs entryways.

* Please store toilet paper on a shelf or cupboard, not on the back of the flush. Please clean and store a child's soother in a storage case when not being used.

*Most all staff have their ECE and curriculum training. I spoke to the Administrator and directed her to consult with the owner about any staff that require the 90 hour Intro to ECE (60 hour orientation to ECE and/or 30 hour Curriculum). Please request that these staff are placed on a waitlist for the training required to meet Regulations. Confirmations should be stored in those staff files. Contact Elizabeth Harvey and forward me the confirmation they are on the waitlist. Thank you.

*Staff need to be planning for a minimum of 1hour of outdoor play opportunities in the morning and in the afternoon. Please ensure children get outside this afternoon to enjoy active play and fresh air. In circumstances when the temperature or windchill is below -20C, the schedule should be flexible to allow changes if the weather doesnot permit children to be outdoors.

*Children going down for a nap during my visit. Children who do not nap were watching the Cat in the Hat. If this is a regular practice, I would limit this activity to once a month.
