General Comments

Monitoring report performed.

*Staff training requirements - The operator received an email which is stored in the identified staff files who are on the waitlist to register for the 60 and/or 30 hour intro to ECE training. Thank you

*Upon arrival the 2 and 3 year old children were being mixed together this AM over the March Break upstairs because of lower numbers. Usually children are separated into their own age group. *Appropriate child guidance was observed, as the Educator encourages children to join them so she can read a story or encourages pleasant conversation at the lunch meal. I would recommend that educators find practices that offer choices to assist children in decision-making when working out their differences. Help children to use their own words to solve problems with their playmates ie. hands off rule.

*The toddlers were enjoying a sensory bin activity during my visit.

*The preschool age group were watching a children's video during my visit after eating lunch.

*Children were observed having bottoms changed and washing hands for lunch.

*Naptimes vary greatly between children. Rest is an important part of the day for all children and benefit from a period of rest for a minimum of 30 minutes. I would recommend that you have a parent statement requesting their child do not rest on a mat when their friends are napping.

*Outdoor play was not observed during my visit. Hopefully the rain will stop in the PM so children have an opportunity to enjoy some active play opportunities and fresh air.

*The operator will need to put a plan in place to accommodate the children that turned 2 years old and remain in the toddler room as there is no room for them to move up to the next class. This is not an issue over the March Break as all children in the front room are 2 and 3 years old. On Monday, toddlers are not to be mixed with 2 year old children at anytime. The children that have turned 2 years old need to be moved on a permanent basis to the 2 year old group respecting room measurements. Please advise your intention. Thank you!
