Learning stories reflect the children's activities and projects that are being completed at the facility. As discussed with the educator, all inclusion support workers must complete the inclusion webinar. Inclusion support workers must never be counted in ratio when the child they are assigned to is in attendance and therefore cannot be left alone with the children.

It is to licensing staff's understanding that there has been changes with the Board of Directors. Please provide criminal record checks for each new member. Also, provide a vulnerable sector check and social development check for those who deal with the finances for the facility.
