General Comments
<p>When I arrived, I was greeted and screened for covid-19 and was given a tour of the centre.</p> <p>The children were very active, lots of smiles and laughter heard throughout the centre. The children seemed happy and well established in their routines. The children were engaged in different types of activities such as; arts and crafts, reading books, playing with blocks and the infants were playing with the foam climber and some plastic balls. Each group also spent time outside.</p> <p>I observed lots of positive child guidance such as gentle reminders and encouragements. The educators are all very engaged with the children. The centre is clean and organized. The children have lots of toys and learning materials to meet their educational needs and interests.</p> <p>I observed an infant fall off the foam climber and hit her head on the floor. The climber was situated at the edge of the mat; therefore, one side did not have protective surfacing. I would ask that the climber be situated in a way that there is protective surfacing on all sides. Please ensure there is no toys near the fall zones of the climber so that if children fall, they don't hit a toy or the wall.</p> <p>I observed hand sanitizer on a table in the Dino Den. Hand sanitizer must be out of reach of children.</p>

General Comments

Diaper changing procedures must be added on the wall in the first bathroom upstairs.
