### General Comments

Upon Licensing staff arrival, the Educators were preparing to take the infants for a walk and while the preschool age children were going outdoors to play. Water bottles were filled up, sunscreen was applied, First Aid kits were taken outdoors as well as the daily attendance logs.

The outdoor space is fully fenced with shaded areas for play. Due to the heat level today, outdoor play time was limited, and frequent water breaks were observed. During play time, the children were observed playing in the sandbox, picking flowers, and engaging in water play at two different water tables. A new wooden play climber, a wooden boat and wooden airplanes have been added to the outdoor space. Educators were observed communicating with each other for bathroom breaks to ensure ratio was maintained, engaging in play with the children, and conducting headcounts before returning indoors.

The indoor classrooms were organized, and play material was in good condition. Children's artwork and family photos were posted in each room. The entry way upstairs was inviting and organized with positive words of affirmation posted. Children's belongings were organized on hooks with their names and classroom doors were decorated with children's artwork. When returning indoors, children were observed washing their hands, changing outdoor shoes, and wet play clothes. The children in the Dino Den were divided into two small groups. One group of children were observed painting together at the tables while the second group played with Barbies, blocks, in the cozy spaces and reading books together. Before lunch, diaper changing procedures were followed and proper handwashing was observed for each group. During lunch, the children in each classroom sat together and Educators were observed assisting children with lunch packaging. After lunch, tables were cleaned, and the floors were swept and mopped. Educators were observed setting up nap cots in each classroom. The transition to nap and quiet time was smooth. Educators were observed rubbing the children's back to help them fall asleep and soft soothing music was played. Children who did not nap were observed playing quietly with open ended and dramatic play material and reading. As the children began to wake from their nap, tables were prepared for afternoon snack and bathroom time and diaper changing was observed.

During inspection, child and staff files were verified and all required licensing documentation was present. Monthly fire drills and outdoor checks are being completed and logged. Allergy information was clearly posted

in visible areas and daily attendance forms were completed. Only positive child guidance was observed during inspection and Educators were actively engaged with the children. There was evidence of purposely planning as detailed learning stories were posted throughout the facility for children to return to reflect on past play. During inspection, a discussion occurred with Administrator to ensure that newly hired Educators are on track for completing Professional Learning hours during the licensing year.

Licensing staff recommends for renewal.
