<ul> <li>During the visit, ratio child-to-staff is maintained and respected in the same age and mixed age groups</li> <li>Daily incident log is maintained, parents are advised and signs the daily log</li> <li>Incident report forms are completed and signed by the parent when in need to fill a reportable incident. The report is sent to the Department within 24 hours following the incident and a copy is given to the parent.</li> <li>Incident reports are maintained in the child's file</li> <li>When acetaminophen is administered to a child, the written and signed by the parent consent is filled into the children file.</li> <li>Administration of medication records are evident</li> <li>Medication is locked and stored in a locked cabinet upstairs and in the refrigerator downstairs they are inaccessible to children</li> <li>Prescribed medication are in the original child safe container with the original label and labeled with the child's name and dosage</li> <li>Daily activities into the center shows purposely planned and documented programming that gives children, Time, and space for a free choice of play experiences, indoor and outdoor opportunities for physical activity either individually or in a group. Children have opportunities for various forms of literacy and to express creativity and interests, to explore the arts and sciences and to experience accomplishment and success. They have opportunities to problem solve and to develop trusting, respectful and supportive relationships.</li> <li>Daily routine into the center includes; Outdoor play time at least once every 4 hour blocks time when the weather is permitting. Meal and snacks are served at the recognized hours and adaily rest period that meets the children's needs.</li> <li>It was discussed with an educator to make sure that the space within each bed is respected, we've discussed different alternatives for positioning the beds and it was confirmed that the beds will be changed the next day.</li> </ul>
