General Comments

Licensing Staff arrived at the facility to perform a Monitoring Inspection. Upon arrival the classes were in the process of finishing up morning snack. Once the children in the 2-year-old class and the 3-year-old class finished eating, they started to get ready to go outside. The children in the 4-year-old class gathered together after snack time to talk about the letter "G". The children had the opportunity to bring something from home that started with the letter "G". One child brought a plush grape toy while others brought a play guitar, gorilla and George the Monkey. The children took turns talking about what item they brought in before passing it around the circle.

Once circle time was finished the children used the washroom before getting ready to go outside. A headcount was observed before leaving the facility. A new wooden play structure has been added to the playground since the last Monitoring Inspection. The children were observed using the climbing wall, steps and the two slides. Other children were observed using shovels to move the snow and using small rocks to "sand" the playground. The 2's and 3's transitioned back inside the facility while the 4-year-old classroom stayed outside. Educators were heard encouraging children to remove their boots, hats and mittens while offering assistance if needed.

Proper diaper changing procedures and hand washing was observed once the children were settled back in their classrooms. The children colored, listened to stories and built igloos out of sugar cubes before cleaning up for lunch time. An extra staff member was on site this morning to assist with preparing the children for outside, bathroom runs and lunch time which made for smooth transition periods. Only positive child guidance was observed. The Educators were observed kneeling to speak to the children at their level and offering techniques with putting on and removing outdoor winter gear to encourage independence. The Educators were patient, calm and showed a genuine interest in the children's activities. A broken ceiling tile was noted during today's Monitoring Inspection. A conversation was had with the Operator who stated the building management is aware and will be replacing the tile.
