Comments: The license posted at the facility indicated a capacity of 45 children and belongs to a different Go-Go location. The correct license must be posted in a visible and prominent location within the facility, as required.

Comments: The daily attendance records did not accurately reflect the number of children present in each group. At the time of inspection, there were four groups of children, each with its own attendance record. However, the records did not correctly correspond to the children assigned to each group. While all educators were aware of the number of children in their care and their locations, the attendance records were not updated when children moved between groups. Attendance records must remain accurate and reflect the names of children in their current group at all times.

Comments:	ents: The attendance records for November 17 and 18 indicate that 65 children were present on November 17 and 64 children on November 18. The center is licensed for a maximum of 60 children. Attendance exceeded the licensed capacity on both days. The operator is required to ensure that the number of children in attendance does not exceed the maximum of 60 as stated on the license.

Monitoring Inspection:

The school-aged children were observed both indoors and outdoors. Indoor activities included board games, coloring, dress-up, card games, Beyblades, and block play. Outdoors, children were engaged in free play and group activities.

General Comments

Educators were observed actively engaging with the children, participating in play, and maintaining positive, age-appropriate conversations. Supervision was consistent, and educators demonstrated attentiveness during transitions between indoor and outdoor spaces.

The following records were reviewed: Incident logs, fire drills, monthly review and maintenance plan for all stationary equipment, and daily attendance sheets.

Recommendations:

- 1. Inclusion Support Workers should not be reassigned to maintain staff-to-child ratios.
- 2. Inclusion Support Workers must be utilized for their intended purpose, providing additional support to the children who require it.
- 3. The management team is to implement procedures to maintain accurate attendance records during transitions.
