<p>Comments: While verifying that all required documents were posted in a visible and prominent location within the facility, the Quality Assurance Monitor noted that the licence displayed was expired. The QAM confirmed on site that the renewed licence had been sent by mail in November. The administrator informed the QAM that the updated licence may have been left on the operator's desk and never posted, but she was unable to confirm this on the day of the inspection.</p> <p>The most current licence must be posted in a visible and prominent place in the facility at all times. The QAM will verify during her next inspection that the required document is properly posted.</p>			

General Comments
<p>The Quality Assurance Monitor was on site to conduct a monitoring inspection.</p> <p>The following elements were verified:</p> <ul style="list-style-type: none"> - Posting - Child records and signed consents - Incident records - Daily activities - Indoor play area materials and equipment <p>Upon arriving at the facility, the Quality Assurance Monitor observed several children in the washroom without any staff present. The QAM could not confirm whether these children were enrolled in the facility or participating in a program offered at the Sports Dome. Regardless, this concern was discussed with the administrator. Children must be supervised at all times when using washrooms located in multi-use buildings and shared with the public.</p> <p>The QAM also noted, while reviewing the daily planning of activities, that a staff member had taken home the binder containing the purposefully planned activities. The QAM was able to review each educator's weekly planning for the current week but was unable to verify previously planned and documented activities. The QAM informed the staff member in question that all planning and documentation must remain on-site at the facility to</p>
