<p>General Comments</p> <p>Licensing staff arrived at the licensed facility to conduct the yearly license renewal inspection when the children were arriving at the centre for the day.</p> <p>While observing the children in both the indoor and outdoor learning environments, the educators used positive child guidance techniques when challenging behaviours occurred. The educators were also seen engaging with the children in play. While observing the children playing in the JDI Irving room, some of the play activities included a small game of mini stick hockey, dramatic play with barbies and cabbage patch kids, Lego and a drawing activity. The educators set up invitations of play for the children before they arrived off the bus to create a smooth transition from school. After snack and free play activities the JDI Irving group of children went to play a game of "rock, paper, scissors tag" before ending their day outside.</p> <p>While observing the children in the RBC group, the children were outdoors engaging in free play activities. A group of children were playing in the sandbox with shovels, rakes, spades and buckets while another group of</p>
