<p><b>General Comments</b></p> <ul style="list-style-type: none"> <li>- Visit completed at the facility in the morning for a monitoring inspection.</li> <li>- Ratio was respected during the visit.</li> <li>- During the visit, positive child guidance was witnessed.</li> <li>- Throughout the facility evidence of purposeful planning based on children's interest and learning, invitation, photos and learning stories were posted.</li> <li>- Facility has a separate locked storage space for medication.</li> <li>- Administration of medication records are evident. Records are kept for each child when medication is administered.</li> <li>- The parent has access to the facility at any time when the child is present.</li> <li>- First aid kit and telephone are accessible on the premises and on each outing.</li> <li>- Toxic products, chemical products and cleaning supplies are locked and inaccessible to children.</li> <li>- Individual space is provided for diapers, creams and wipes for each child who is not toilet trained. Diaper changing procedures are posted in a visible place in the diaper changing area. Children are always supervised during diaper changing.</li> <li>- Observations:            Infant room: During free play the educators were sitting on the floor talking with the children. The children were looking at books, playing with dinosaurs and trucks.            2-year-old room: Diaper changing was witnessed. The children participated in free play activities. The children were playing with Lego and looking at books. The educators were engaged in the children's play.            3-year-old room: The children were participating in free play activities. They were "trapping Ninja turtles". The educator was discussing with the children.            4-year-old room: The children were drawing pictures and doing puzzles.            Parent arrival was witnessed during the visit. All groups of children had their lunch.</li> <li>- Discussion with the educators on medication.</li> </ul>
