- Administrator will put a plan in place to ensure that the outdoor play area is verified regularly for any items that could affect the safety of the children.

Observations:

- Infants did free play and educators were sitting on the floor with them. Some were interested in farm animals, pop its, vehicles and more.
- The two-year-olds were doing free play and then went outside.
- The three-year-olds were painting a house drawing with the colour of their choice.
- The four-year-olds talked about the date, colours and numbers. The numbers were roads that they could play with cars on.
- All groups ate their lunch and had their rest period.
