<p>Renewal inspection completed in p.m.</p> <p>Two groups of school-aged children are present. The ratio is respected.</p> <p>During the visit, preschool-aged children were observed playing freely, eating snacks, participating in a group activity, and playing in the outdoor play area.</p> <p>The playground was also inspected. A discussion was held to ensure that the playground is raked regularly to maintain sufficient protective surface.</p> <p>A discussion was also held regarding the first aid course that must be renewed by the end of September for one educator. She is registered and will take the training in the coming weeks.</p>
