A monitoring inspection was conducted today on the school-age program. Children were observed washing hands prior to snack, snack and getting ready for outside play.

The children have a variety of materials in all rooms to interact and engage with, with the exception of the art room where creative art materials were lacking. However, this was addressed during the inspection today.

The outside play area has had a slide installed into the hill and the children seem eager to be able to use this area once completed. The children observed appeared happy in their environment and with their educators and the educators were observed speaking respectfully to the children and engaged with them.
