General Comments

A renewal inspection occurred today.

Lady Bugs Room: When licensing staff arrived, the children were dressed to go outside. The educators shared with licensing staff that they planned to have a Valentine's Day celebration in the afternoon. The infants were observed having lunch, and dancing to music before laying down for a nap.

Kangaroo Room: The children were having a dance party when licensing staff arrived. The children then got ready to go outside. Licensing staff observed the educators encouraging the children to try to get dressed on their own. The children showed a sense of pride as they celebrated getting their winter gear on independently.

Monkey Tails Room: The children were excited to share with licensing staff that they were getting ready to go outside to take part in a heart scavenger hunt. The educator in the room gave some of the children the option to be her helper, by helping her hide the hearts outside. The other children were then invited to search for the hidden hearts in the snow.

Chickadees Room: The children were observed making Valentine bags in the art area. The children were excited to share with licensing staff that they had a Valentine's Day celebration planned for the afternoon. The children were excited to hand out their Valentines to their friends and educators.

Firefly Room: The children were observed creating Valentine bags in the art area, playing with trains, train tracks, and coloring. The educators in the room were both observed engaging with the children. The children were observed taking part in a Valentine's activity called "How Many Kisses Tall Are You?" The educator measured each child with Hershey Kisses.

Transitions in all rooms ran smoothly. All classrooms were observed going outside, washing hands, during mealtimes, and nap time. The educators were observed having positive interactions with the children. The classroom environments were calm, and all areas of the rooms had materials that were age appropriate, down at the children's level, and open and ready for all children to explore throughout the day.

General Comments

Documentation of winter and Valentine's Day were present alongside pictures of the children throughout each classroom.

The following records were reviewed: Incident logs, fire drills, educator professional learning hours, infant toddler daily sheets, nap sheets, and daily attendance sheets.

All staff files were viewed, and a random review of the children files was completed.

Facility is recommended for licensing pending Fire recommendation.
