General Comments

The children were observed to be actively participating in play within the interest centres. Educators were interacting with the children at their level and providing the children with opportunities to expand on their learning through conversation.

A balance of indoor and outdoor play occurred. The preschool children moved seamlessly through the activities of the morning indicating that they are familiar with the routine of the day.

General Comments

The preschool children's portfolios are being maintained and evidence of documentation supports the children's learning based on their interests. Displays of the children's art and mark-making are valuable additions that are posted within their learning environment.

Discussed purposeful programming for the school age children and the importance of capturing their interests through experiments, project work and so on. What are the children talking about? What would the children like to explore? Also discussed open-ended art and the importance of creativity and imagination.
