General Comments

A renewal inspection occurred in the preschool room. The environment in the school-age room was inspected as well, however, no children were present in the school-age room.

The educators were observed having positive interactions with the children. A morning meeting was observed, where they sang songs and read stories. Children could either participate in the morning meeting or continue their play in the learning centers. Educators recognized the children's cues during morning meeting and those that did not want to continue to listen to the story were permitted to engage in other activities in the learning environments.

Outdoor play was also observed. Children were splashing in mud puddles and taking turns sliding down the slide. Educators were observed positioned throughout the outside play area properly supervising the children at all times.

Recommendation:

In the Mighty Ducks room, a latching wooded gate in the opening of the loft, so children feel more secured while using the area.
