Completed the renewal inspection today.

The children are exploring a variety of topics of interest within their bubble groups. Evidence of their learning is documented in different forms (webbing, photos, print, mark-making, creative art, etc.) and enhances opportunities for continued conversation and reflection on recent activities and experiences. The learning environments are set up with toys and materials that are available and accessible to the children. Educators were observed to be engaged with the children and to provide guidance in a positive way. The children were familiar with the routine of the day and they demonstrated excitement for outdoor play.

General Comments

The trim of the playhouse in the outdoor play area will require painting when the weather permits.
