General Comments

A monitoring inspection occurred on this license. Inspector reviewed attendance records, incident logs, daily information sheets, medication records, five new staff files and documentation and planning of the children's learning.

The children were observed by the Inspector engaged in play in the learning environments for each room as well as two groups of children were observed preparing for outside play.

In Room 9, Inspector observed children napping, educators signing songs to the children, children being rocked to sleep and educators reading stories to the children. Documentation in the room depicts the children's current interests and exploration. Pictures of the children engaged in making music, sensory exploration with textures, painting and outside play were observed. In the indoor environment pictures blocks of the children, families are educators were observed.

In Room 10, Inspector observed the children engaged in reading with their educators, exploring with salt dough in the tuff tray, and finishing morning snack. Documentation of the children's mark making and art were observed displayed on the walls in the learning environment.

In Room 12 the children have been exploring leaves, colors, loose parts, painting, exploring the snow. Pictures

of the children engaged in these activities are documented and displayed on the walls of the learning environment. Children have also been exploring numbers and math, and educators have created items using loose parts, cardboard and materials showing numbers for the children to explore and learn.

In Room 11 the children were observed by the inspector preparing for outside play and singing songs during morning meeting. Inspector observed documentation in this room of the children exploring paint with brushes and fingers, building blocks, and samples of the children's mark making was displayed.

Educators in all the rooms were observed tending to the needs of the children, interacting with them down at their level on the floor, and speaking kindly and appropriately to them.
