A Follow-Up Renewal Inspection was completed this morning.

Administrators are in the process of getting fencing quotes, and administrators have stated that the plan is, to have a proper fence in place, by September 2023. QAM to conduct a monitoring visit in September, to ensure that fence has been added.

Three staff have not completed their 16-hour Standard First Aid with CPR Level C training. All 3 staff have recently completed the online portion of this training. All three staff are in the process of booking and completing the in-person component. Staff who have not completed their First Aid with CPR Level C training, are not to be left alone with children.

One member of the Board of Directors is missing their Criminal Record / Vulnerable Sector Check.

Administrator stated that the paperwork has been sent in, and that they are waiting for the completed document.
