**General Comments**

The Quality Assurance Monitor was on site for a monitoring inspection. Ratio was respected during the visit.

When the Quality Assurance Monitor arrived on site, children were having a snack. The Quality Assurance monitor was able to observe children transition from snack time to outdoor play. During outdoor play the Quality Assurance Monitor was able to observe the supervision of children while playing outdoor. The Quality Assurance Monitor was able to observe educators always playing with children and supervising children.

The Quality Assurance Monitor was also able to observe children transitioning from outdoor play to lunch time. When children were brought in, the Quality Assurance Monitor noticed that when children lined up to go inside and a head count is done to ensure that educators have all children the children are then given the OK to go inside. The Quality Assurance Monitor noticed some children playing in empty rooms when they came in and did not follow their group into the proper classroom. The Quality Assurance Monitor also heard an educator asking other educators if some of her children were in their class. When Quality Assurance Monitor brought this to the operator, the operator explained that today was the first day of class transitioning and some children could be mixed up and maybe that's why certain children didn't follow their group in the proper classroom. The Quality Assurance Monitor was able to confirm that the children were not roaming around in the wrong classroom for more than 3- to 45 seconds. Both the Quality Assurance Monitor and Operator agreed that maybe for the first couple of days each classroom should come in separately until children get use to the new routine with the new class.

The Quality Assurance Monitor was also able to observe lunch time and the transition from lunch time to quiet time. The Quality Assurance Monitor heard some children ask to have alone time during quiet time, the educator respected his needs and ask the other children if they could give them their space as they requested for quiet time.

The quality Assurance Monitor observed that when children were done eating, they are asked to go to the cozy corner while the educator clean up from lunch. The Quality Assurance Monitor noticed that the cozy corner is a

bit cornered off from the rest of class making it hard for the one educator too clean up from lunch and have full supervision on the children although the Quality Assurance Monitor notice that the educator was very attentive and as soon as the educator would hear something coming from the cozy corner , the educator would rush to the corner to verify the situation.
