General Comments

Monitoring visit performed. Upon arrival all children enjoying their morning outside. There are more than enough educators on site to maintain ratios during breaks and lunches. This is great!

I walked down the hill to the group of toddlers that were playing in the field. One educator was sitting under a tree with 2 children and the other 4 were playing around the giant tire and the educator was engaged, and ensuring the children were safe, paying attention to the children's movements. They eventually walked up to the outdoor play area where there was more shade and children played for a while before moving indoors to clean up, eat lunch and go for a nap.

This was national mud day at this centre and the 2,3, and 4 year olds were enjoying their morning at the creek, playing in the water, making mud cakes, exploring their surroundings etc. When they headed back to the centre for lunch, most everyone, including the educators were covered in mud. The outdoor play area is inviting - lots of natural and created environments which values culture and diversity. There are places for children to sit by themselves, in groups, or at a table. The forest school has a wash station. Children made a community of teepees, planted a garden which provides strawberries, carrots and peas during the summer months. etc. The school age group spent their morning at the park and the other group were taking swimming lessons at the Ayr Motor Centre. They have a 30 minute lesson and 30 minute free swim. Life guards on site at all times. Preschool children were observed eating their lunch and going down for a nap or quiet time. Educators were observed engaged in conversation and sitting with the children during the meal.

Lots of wonderful programming posted inside the centre at children's eye level which references the curriculum framework.

General Comments
A couple of observations - 1. when the diaper change mat is not in use, please store off the floor for sanitary reasons. 2. during my visit I observed a Tim's coffee sitting on a shelf that would be easily accessible to children. The coffee was cold at the time, however please remind staff they are not permitted hot beverages in areas where children play including the outdoor play area. 3. it is a recommended practice to carry your attendance record while off site on field trips away from the centre, so the educator can document the time when/if a child is picked up by a parent.
