The educators set up stations for the children to engage with. There was a craft station where the children made their own fish out of construction paper and tape. Along with the craft station there was a game station where the children read a card and then drew what the instructions asked them to draw. The third station was a car station where a group of children had a variety of small cars with a race car mat to run the cars on.</p> <p>The educators were seen interacting with the children at the child's level.</p> <p>The centre was very clean and organized and ran very smoothly during the time of the inspection visit.</p>
