<p>General Comments</p> <p>At the time of the follow-up visit the younger group was washing up and then sitting down for snack. The snack for this day was mini pita pockets with tzatziki sauce and apples. The children enjoyed this snack as they were asking for second helpings.</p> <p>Child-to-staff ratio was more than within regulation according to the Early Childhood Services Act.</p> <p>When the older children arrived, they washed up for snack. They also had mini pita pockets, tzatziki sauce and apples.</p> <p>During the follow-up inspection visit, licensing staff noted that the medications were locked up with a key and lock in a two drawer mini filing cabinet. Licensing staff also noted that the allergy information was posted in both the entrance of the small gym, as well as, inside the gym where snack is served.</p>
