General Comments

Upon the licensing staff's arrival, the children were not yet out of school. The educators started setting up the gymnasium around 2pm. Tables were brought in the gym for snack time. One educator was observed sanitizing the tables while the other educators set out invitations for the children to play with. Tennis and badminton rackets, arts and crafts, books and hula hoops were set up.

Around 2:30pm one educator went to greet the children in the hallway. The educator was seen taking the attendance and completing a head count. As the children entered the gym, another educator greeted them and offered them a snack. Each child had a place mat with their names on it set out on the table. The educator offered the children options for snacks and as the children asked for more food the educator agreed. While some children ate their snacks, others engaged in free play activities such as arts and crafts, reading, and making bracelets. The educators were observed floating from group to group and engage in the children's activities. One educator read a book while another played badminton.

Once the children had completed their snack, the educators asked the children if they wanted to go outside. The children agreed and the educators gave the children 15 minutes until it was time to clean up and get ready to go outside. The educators used a clapping strategy to get the children's attention while transitioning from one activity to the next. The children cleaned up and got ready to go outside. While outside the children engaged in free play activities. The educators were observed playing hide and go seek and grounders with the children while outside.

The educators were observed kneeling to speak to the children, asking the children questions and actively listening to the children while they spoke. The educators were observed encouraging collaboration and respect between the children. The educators were patient and caring towards the children at all times. The educators communicated to each other every time one of the children left the facility or whenever they were stepping out to supervise a child using the washroom.
