<b>General Comments</b>
<p>Visit to facility this morning for annual inspection during COVID-19 period. Inspection took place in the morning, school aged children were not present.</p> <p>Comments in relation to non-compliances of regulation 10(7) and 9(1): Ratio was not respected upon my arrival to facility. Infants were mixed with preschoolers and only one educator was present in the facility. Educator arrived shortly after and infants were grouped together in their room.</p> <p>Discussed with the operator that regulation 10 (7) states that infants shall not be grouped with other children and that educator must be present with group at all times. It was also discussed this this is not the first time this regulation that has not been followed and that her exemption request for grouping infants was denied.</p> <p>Reminded operator that infants must nap, eat and go outdoors separately from other groups. Infants attending the facility at this time will be turning 2 in the next four months. The operator is requesting a new exemption for infants to be grouped with other children at this time.</p>

General Comments

Recommended that infant room zones be developed, for example access to art supplies, a table area and literacy area. Requesting pictures be sent to inspector once this is complete.

Reviewed COVID-19 regulations and procedures with the operator. Recommended plush items be washed daily / be put in isolation when used. Advised items/natural elements that cannot be washed be discarded at the end of use. Reminded operator that children must wash their hands before eating.

Recommended children's bedding be stored individually.

Hot lunch menu was posted on parent board, operator posted snack menu while I was present. Snack menu should always be posted.

Ensure that all child profiles are complete with the full addresses of emergency contacts and the addresses of people who have permission to pick up children.

Recommending that more outdoor toys be made available to children.

Facility is awaiting health inspection.

Observations:

Preschoolers read stories with educator on a floor matt together.

Infants played with farm animals.

Children also had lunch during inspection visit.
