General Comments

-Follow-up inspection to the center to ensure that the outdoor play area includes a shaded area that is at least 10% of the outdoor play area. A tarp was set up has a shaded area, longer post will be put in to make the tarp higher, but children can still play in the shade.

-New material for the outside space is in order, operators will send pictures once they are received.

-Routine of the day was discussed with the operator, it was suggested to create a routine that will set structure and boundaries to ease the flow of the day.

-Operator confirms that ice pack are into the lunch boxes, if not food is stored into the refrigerator.

-Children are into creating their own board game, they were having a vote on which game they were going to create.

-When arriving at the center, operator was away to get a child, one staff was left with 3 preschool kids and 12 afterschool, which means that they were off ratio for a short period of time. It was explained to the operator the 4-5year-old kids ratio counts has preschoolers until they set foot into the school system. Operator confirms that she will be attentive, and it won't happen again.

Observations: When arriving at the center a small group of children were finishing their lunch, some were into building with large wooden blocks, others were involved in building a train track, some were painting, drawing or playing with large balls.
