Comments: One of the children's files was missing the telephone number of an emergency contact. This information was added to the file while inspector was on site. Deficiency is now compliant

Comments: One staff has not signed the statement regarding their obligations under the Act and licensing regulation. Operator must ensure that this information is indicated in all staff files.			
33(2) Stationary equipment in the outdoor play area shall be surrounded by a protective surfacing and installed according to the manufacturer's instructions.	33(2)	Jun 28, 2022	
Comments: During the inspection, inspector observed missing protective surfacing underneath the slide and swings. A discussion was had with the Operator regarding ensuring that protective surfacing is added to these areas. Until then, children may not use this equipment.			
48(2) An operator of a licensed facility may supply food to a child receiving services at the licensed facility that a parent or guardian of the child brings from the child's home if the food is labelled with the child's name and refrigerated, as required.	48(2)	Jun 21, 2022	Jun 21, 2022
Comments: 3 of the children's lunch boxes were not labelled with the child's name. Food brought from home must be labelled with the child's name. While inspector was on site, the children's names were added to identify their lunch boxes. Deficiency is now compliant
