Comments: During the renewal inspection, the inspector observed that the inspection sticker of the van expired on December 31, 2022. The vehicle must be in compliance with the Motor Vehicle Act and the regulations under that Act before it can be used to transport children.

Comments: During the renewal inspection, the inspector finds that daily activities are not deliberately planned. The operator must ensure that programming is deliberately planned and documented. Operator must demonstrate that planning is a process that involves engaging the children and reflecting on the children's interests, passions, strengths and abilities.

Comments: During the renewal inspection, the inspector observe that the name and number of the inspector is not posted in a visible area inside the facility. During the inspection, the name and number of the inspector was placed on the main billboard. Deficiency is now compliant.

Comments: During the renewal inspection, the inspector observed that the absence codes are missing for 2 out of 7 children. During the renewal inspection, the operator indicated the reasons for absences. Deficiency is now compliant.			

General Comments

During the renewal inspection, the inspector observed snack time, indoor free play and a fire drill.

During the inspection, the outdoor playground is covered with snow, therefore the inspector was not able to verify if more than one type of material allowing different types of activity is offered. It is recommended not to use the large play structure in the park since the ground is frozen. Park assessment will be done in the spring
