Comments:	During the inspection of two infant classrooms, the inspector observed that art materials are not placed on low, open shelves accessible to the children. The inspector informed the administrator, who then discussed the matter with the educator. As a result, some art materials were placed on low, open shelves to ensure accessibility for the children. Deficiency is now compliant.

Comments:	During the inspection of the diaper changing surface, the inspector observed that the mattress had visible tears. It is important to note that changing surfaces must be covered with a waterproof and easily cleanable material. A torn mattress is difficult to clean properly, which compromises disinfection after each use.

Comments: During the inspection, the inspector observed that the diaper changing procedures are not posted in one of the designated diaper changing bathrooms. The inspector notified the administrator, who posted the procedures on the bathroom wall. Deficiency is now compliant.

In one classroom, the inspector observed a Halloween-themed book being read to the children. In another classroom, children are engaged in decorating bags for Halloween.

A discussion is held with the administrator to clarify that eligible educators must complete the required 10 hours of professional development before the permit expiration date of December 31, 2025.
