The Quality Assurance Monitor had a discussion with the educator in charge regarding designation requirements. The educator in charge confirmed that the Quality Improvement Plan is current, and all eligible educators are actively completing their required 10 hours of professional learning per renewal year.

The Quality Assurance Monitor observed that one educator's file was not on site. The administrator must ensure that all educators in the facility have a complete file available on site. The educator in charge promptly retrieved the missing file from their other facility. The Quality Assurance Monitor recommends that all staff files be maintained and readily available at both facilities.

During the Monitoring Inspection, children were observed playing outside, exploring the outdoor playground for leaves, participating in group time, and engaging with the story 'Five Little Ghosts' using a felt board. The transition from lunch to nap time was also observed.
