General Comments

Renewal inspection completed today.

The part time preschool children were not observed today as it was not a preschool day.

The grade K/1 room children went outside shortly after arrival. Hand washing routines were observed. This room has displayed photos of the children on poster boards around the room and these have been positioned at the children's level to review. Ensure dates are recorded on documentation pieces and that documentation is kept up to date.

Coloring pages were observed posted on the bulletin board as choices for children to select. Educators should not be offering colouring pages but instead setting up invitations for open ended art. There was a variety of creative art materials organized within the art shelf of this room. How could these be set up for the children to explore in an open ended way?

The grade 2/3 room was set up with a variety of invitations for the children to explore based on their interests upon their arrival. Some children were observed within the dramatic play area, and were also observed drawing, building, making collages and books and exploring open ended art (ex: water colour painting). Some new materials were added to the room today (ex: colored nesting/building blocks) which were used by many of the children.

Documentation was displayed around the room in the form of posters, drawings, jokes, and models.

Within the grade 4/5 room children were engaged in reading books within the cozy area and building with clay. The children reported that they had recently made some ornaments for the Christmas tree within their room.

General Comments

These children had a variety of books to choose from and books have been organized and displayed neatly within an open closet. Some totes of materials and boxes were in front of the book shelf today. Ensure materials are tidied and stored in an organized way to ensure access to this area. Additional documentation and purposeful planning is needed within this room to demonstrate and support children's interests.

There is a digital camera accessible to staff to take photos of the children. Discussed the idea of displaying the children's photos on a digital photo frame for them to revisit/review past experiences.

A relief staff member was not aware of an allergy within their group today. All staff must be aware of children's allergies. These are posted within cabinets in the rooms, but staff must be well informed of life threatening allergies, where medications/Epipens are stored and what action is to be taken in case of emergency.
