<p><b>General Comments</b></p> <p>Advised operator that medical forms are no longer required for staff files. Filing system is well organized and complete with all documentation required for licensing purposes.</p> <p>Management of illness policies are being followed by filling out required forms, notifying parents of communicable diseases and having parent(s) report absences due to illness.</p> <p>There is a planned and documented program evident for the school age children. Children are offered a variety of equipment and toys to enhance their learning.</p> <p>Incident reports and non-reportable incidents are evident. Advised Operator that it is not recommended to use government forms for non reportable incidents however if they choose to continue to ensure that the reportable and non-reportable incidents are kept separately and in chronological order. Operator stated that they were going to put reportable incidents in a separate file.</p> <p>Facility uses a numbering system for labelling children's cubbies. They use the cubby that corresponds to their number. The children do have space for their personal belongings and it is stored separately.</p> <p>I spoke to a staff regarding having a hot beverage in the children's play area. It is to my understanding that they are a new staff. The beverage was taken out of the area immediately.</p> <p>The educators engage in conversation and play with the children. They continuously interact and give gentle reminders where needed. I observed an educator trying to get the children's attention and did so by keeping their voice level and quiet. Children stopped what they were doing and listened to the educator.</p> <p>A new fire inspection is required and once received I can recommend for licensing.</p>
