The cover was missing on the outdoor bin which protects the toys from the weather. | | | |

General Comments

During this monitoring visit, children were observed in outdoor play. The babies played outside at a different time. This outdoor space is shared with the other licensed facility. Children were observed playing in the tunnel, practicing their gymnastics practicing their skills on the ride on toys (lots of ride on toys). There are lots of toys for the sandbox to scoop and fill and measure the sand. Educators were engaged by responding to children's needs, encouraging children to test their limits at gymnastics, and kneeling down to speak children.

Administrative records were reviewed - attendance, infant toddler info sheets, fire drills, incident reports, and outdoor maintenance is tracked. In regard to outdoor maintenance checklist, there is a gap at the bottom of the fence in the back on the left side where a 4 x 4 wooden fence post has been placed temporarily. Licensing staff observed alot of growth of shrub and bushes under, around and through the chain link fence which is pulling it down and maybe less than 4 feet in height in places. Recommending repairing in the spring before next annual inspection to ensure you are in compliance with regulations.

Indoors licensing staff observed new table and chairs, new mats in the infant and toddler rooms. Toys and equipment is displayed on low open shelves and bins are labelled. The babies love to pull off the labels, so the educators are experimenting with other ways to keep the labels secure.

Positive child guidance was observed - educators were overheard saying "you guys are awesome, using playful conversation while changing diapers, speaking to children using kind words, and soft tones.

All children observed eating lunch. Once babies finished eating lunch and their face and hands were wiped with

their own washcloths, they were permitted to play until ready for a nap. Educators were observed assisting children with lunches or helping with eating. In the 2's room, educators sat and ate their lunch with the children. All children observed going down for a nap and educators played calming music. All children are being introduced to remembrance day activities and poppy art was displayed in all the rooms.
