Comments: When the Quality Assurance Monitor arrived on site, she noted that a preschool child was outside his classroom, at his cubby, without supervision. Although child-to-staff ratios were respected inside the classroom, one child had been left unsupervised. When preschool children leave the classroom—especially when the classroom door is closed—they must be supervised at all times. The Quality Assurance Monitor discussed with the administrator the importance of providing adequate supervision. The administrator informed the QAM that she will be addressing this matter with her staff. Deficiency is now compliant

Comments: During the child records review, the Quality Assurance Monitor noted that several consents for transporting the child or providing transportation were missing. The administrator immediately realized that the transportation consents for preschool children who moved to the after-school program in the fall had not been updated. All children receiving transportation services from the facility must have a signed consent form in their file.

any staff present. The QAM could not confirm whether these children were enrolled in the facility or participating in a program offered at the Sports Dome. Regardless, this concern was discussed with the administrator. Children must be supervised at all times when using washrooms located in multi-use buildings and shared with the public.

The QAM also noted, while reviewing the daily planning of activities, that a staff member had taken home the binder containing the purposefully planned activities. The QAM was able to review each educator's weekly planning for the current week but was unable to verify previously planned and documented activities. The QAM informed the staff member in question that all planning and documentation must remain on-site at the facility to allow licensing staff to review them when required

During the inspection, children participated in a variety of staff-directed games. Children appeared engaged in play.
