<p>General Comments</p> <p>Licensing staff arrived at the early learning facility while the children were outdoors playing.</p> <p>The children went inside for lunch and quiet time.</p> <p>All educators were engaged with the children. The educators were observed to very attentive, nurturing and engaged with the children at all times during the license renewal inspection visit.</p> <p>The indoor environment was very welcoming and calm which in turn created a very calm and nurturing environment for the children.</p> <p>Licensing staff observed a huge variety of evidence of learning posted on the walls. There was a great variety of learning centres, in both classrooms, for the children to engage in that were created based on the children's interests. The children were observed learning about sea animals. I heard a conversation between an educator and a group of children which was predominantly about the habitat of a lemon shark.</p> <p>Once the children had lunch and had some quiet time the children went back outside to have some water play. The children went slipping and sliding on a "slip and slide" game that an educator brought in for the children. The children were heard giggling the entire time while outside. The educators also brought out water spray bottles for the children to have a friendly water "fight."</p> <p>While conducting the inspection it was noted that even though the cleaning supplies and other toxic materials</p>

were secured in a cupboard with a child safe lock, the cleaning supplies and other toxic materials are required to be secured by a lock and key in order to maintain the safety of the children. It was also observed that one of the wooden shelving unit located in one of the classrooms had nails that were popping up. When this was brought to the educator's attention she immediately relayed to licencing staff that she would hammer the nails down.
