General Comments
<p>Licensing staff arrived at the license facility on July 12th, 2024, to conduct the follow-up license renewal inspection.</p> <p>Licensing staff arrived at the facility while the children were still being dropped off for the day. The educators showed great compassion towards the children who were a bit reluctant to leave their parents. The reluctance was very short-lived, as within minutes, the children found their friends and began playing.</p> <p>While observing the children playing in the outdoor play environment, licensing staff observed multiple balls (basketballs, volleyballs, footballs, different sized whiffle balls), multiple rackets, skipping ropes and a parachute.</p> <p>The educators are very engaged in play with the children. Licensing staff observed rich conversation between the educators and the children throughout the inspection visit. Some of the conversations included butterflies, plans for the weekend coming up, spiders, snakes and earwigs just to name a few.</p> <p>The activities today were dancing in the gym or doing crafts in the craft room. While observing the children and educators dancing and singing in the gym, the children were permitted to choose the songs and were observed singing and dancing.</p>

General Comments

While observing in the craft room, the children were given an abundance of materials to create with. The materials were tissue paper, scissors, construction paper, glue, and pipe cleaners. All creations looked different. The educators in the craft room were very encouraging and observed asking the children if they would like to make multiple creations! Well done!!
