Comments: During the renewal inspection, the inspector observed that the signed statement from parents confirming they have read and understood the parent handbook is missing in 1 of the 12 files verified. Comments: During quiet time, the inspector heard an educator shush loudly and say: "I don't want to hear any more words coming from your mouth, it's nap time". The operator must ensure that the guidance of the children receiving services at the facility is positive. Positive child guidance techniques are used to support and encourage children in learning independence and appropriate acceptable behavior. These practices help to develop relationships that promote children's well-being and sense of belonging. The inspector requires that all staff members read section 8.2 of the Operator Manual for Full-time and Part-time Early Learning and Childcare Centres.

Comments: Upon arriving to the facility, the inspector observed four preschool children alone in a classroom while one of the educator's was in the hallway with a child and the second educator was conducting a diaper change. The inspector also observed one educator supervising a group of 4 infants. During the inspection, the inspector is informed that the second educator is supervising another group of children. Immediately after notifying the administrator, the educator returned to the infant's room. The inspector also observed that 10 children were left with once educator while the second educator went to heat the children's lunches. The inspector recommended that the educator bring five children with them to heat the lunches in order to respect the ratio. The operator must ensure that the child-to-staff ratio is maintained at all times. Deficiency is now compliant.						
General Comments						
During the renewal inspection, the inspector observed educators reading books to children, snack time, indoor free play, lunch, quiet time and outdoor free play. The inspector also observed that in 1 of the 6 classrooms the children only had access to wax crayons in the art						
and creative area. The inspector recommends adding a variety of crayons, markers and paint to the art area.
