Comments: During the follow-up inspection, the inspector observed that a child's health history including a copy of the immunization record, or a copy of the exemption is missing in one of the 6 child files audited. The operator must obtain a copy of the children's immunization records and place it in their file.			
26(2) The operator of a licensed facility shall require the parent or guardian referred to in subsection (1) to sign a declaration confirming that he or she has read and understood the content of the handbook.	26(2)	Nov 20, 2023	
Comments: During the follow-up inspection, the inspector observed that the signed statement from parents confirming they have read and understood the parent handbook is missing in 1 of the 6 files verified. The child's file must include the signed statement from parent confirming they have read and understood the parent handbook.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (b) permitting, in the case of illness or soiled clothing, the child to shower or bathe or showering or bathing the child.	27(b)	Nov 20, 2023	
Comments: During the follow-up inspection, the inspector observed that consent for bathing or showering in the event of illness or soiled clothing is missing in 1 of the 6 child files audited. The operator must ensure that consent for bathing or showering in the event of illness or soiled clothing is provided by the parents.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (c) permitting the administration of medication in the circumstances set out in section 46.	27(c)	Nov 20, 2023

Comments: During the follow-up inspection, the inspector observed that consent for outings and excursions off premises is missing in 1 of the 6 child files audited. The operator must ensure that consent for outings and excursions off premises is provided by the parents.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (j) permitting photographs and videos to be taken of the child for publication or social media.	27(j)	Nov 20, 2023	
Comments: During the follow-up inspection, the inspector observed that consent for permitting photographs and videos of child for publication on social media is missing in 1 of the 6 child files audited. The operator must ensure that consent for permitting photographs and videos of child for publication on social media is provided by the parents.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (k) posting photographs of the child at the licensed facility to illustrate the child's learning.	27(k)	Nov 20, 2023	
Comments: During the follow-up inspection, the inspector observed that consent for posting photographs of child in the centre to illustrate learning is missing in 1 of the 6 child files verified. The operator must ensure that consent for posting photographs of child in the centre to illustrate learning is provided by the parents.			
30(3) An operator shall maintain the indoor play area of a licensed facility to ensure the safety of the children.	30(3)	Nov 20, 2023	
Comments: During the follow-up inspection, the inspector that the 3-year-old room has been painted and that the wall has been drywalled in 4-year-old room but that it has not been painted yet. The operator must repaint the wall so that it is easy to clean.			
32(1) An operator of a licensed facility shall provide indoor play area materials and equipment that are (d) clean and in good repair.	32(1)(d)	Nov 24, 2023	Dec 19, 2023
Comments: During the follow-up inspection, the inspector observed that the two Adirondack chairs and damaged books have been removed from the play area. Deficiency is now compliant.			
36(6) A cot, a nap mat or the mattress of a crib or portable playpen shall be washable and non-absorbent or covered with a non-absorbent layer.	36(6)	Dec 01, 2023	
Comments: During the follow-up inspection, the inspector observed that 5 out of the 10 nap mats verified have tears. As requested on November 21, 2023, the operator must ensure that nap mats are washable and covered with a non-absorbent layer.			
46(1) An operator of a licensed facility shall only administer medication to a child receiving services at the licensed facility in the following cases: (c) if the medication is not prescribed, the medication is (i) in the original container with the original label, (ii) in a container with child protective caps (iii) labelled with the child's name and the dosage.	46(1)(c)	Nov 20, 2023	Dec 19, 2023
Comments: During the follow-up inspection, the inspector observed that a bottle of Advil is not labelled with the name of the child. During the inspection, a staff member removed the bottle from the facility. Deficiency is now compliant.			
47(1) An operator of a licensed facility shall refuse admission to a child if satisfactory proof of the immunizations required by the Public Health Act or the regulations under that Act is not provided.	47(1)	Nov 20, 2023	
Comments: During the follow-up inspection, the inspector observed that a child's health history including a copy of the immunization record, or a copy of the exemption is missing in one of the 6 child files audited. The operator must obtain a copy of the children's immunization records and place it in their file.			
49(1) An operator of a licensed facility shall ensure that the guidance of the children receiving services at the licensed facility is positive and includes positive reinforcement, encouraging efforts and recognizing accomplishments.	49(1)	Nov 16, 2023	Dec 19, 2023
