Comments: During the follow-up inspection, the inspector observed that the signed statement from parent confirming they have read and understood the parent handbook is present in the 5 child files audited. Deficiency is now compliant.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (c) permitting the administration of medication in the circumstances set out in section 46.	27(c)	Dec 20, 2023	Jan 17, 2024
Comments: During the follow-up inspection, the inspector observed that consent for administering medication is present in the 5 child files audited. Deficiency is now compliant.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (f) permitting the child to participate in an outing.	27(f)	Jan 24, 2024	
Comments: During the follow-up inspection, the inspector is informed that the children are on an outing at Judo Otoshi Riverview but that consent forms indicating the date, time, description of the activity and the parents signature are not present in the children's files. An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before permitting a child to participate in an outing.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Jan 17, 2024	Jan 17, 2024
Comments: During the follow-up inspection, the inspector observed a can of interior paint in an unlocked office. During the inspection, the administrator placed the paint in a locked cabinet. Deficiency is now compliant.

Comments: The inspector is informed by the administrator that no incidents have occurred since the last inspection. The administrator is aware that all incident logs must be signed by the parent / guardian. Deficiency is now compliant.
