The educator explained that the staff in questions was an educator from the other facility and her staff file must still be at the other facility. The Quality Assurance Monitor reminded the educator in charge that if the staff in questions does not have records on the site, they must leave the premises. The educator in charge immediately called the administrator, who was able to bring the staff in questions file within 15 minutes to the facility.
