Comments: Infants' daily information sheets did not have recorded nap times, meals or changing times. Discussed with educator during inspection.

Comments: Door between twos and preschool has broken transition piece on floor. Needs to be replaced/fixed.

Comments: Bottom of Preschool clothing bins are dirty. Need to be cleaned.

Comments: Paint cups in art easel, preschool room, was dried out. Need to be cleaned and replaced.

Comments: Nap Mats: * One orange mat has a hole-Mat needs to be replaced or fully re-covered *One red mat has duct tape. Mat needs to be replaced or fully re-covered. Discussed with operator during inspection.

Comments: Bottles were not labeled. Discussed with educator in infants' room, when there is more than one bottle, each bottle needs to be labeled. Educator corrected during inspection. Deficiency is now compliant.			

**General Comments**

A renewal inspection occurred today. The children were observed both in inside and outside play. The children in preschool came in from outdoor play and washed hands to prepare for lunch. Hand washing was discussed with educator in infants' room, to be done after each diaper change.

Documentation for purposeful planning was discussed with educators. Only one web was observed in the twos room, no program binders or planned activities were observed.
