This is a follow up monitoring inspection.

Licensing staff received an email from the operator on October 27th indicating the date the Orders for compliance were completed for the above items.

The requirement for the outdoor play space was discussed further and once this space has been set up and is meeting the requirements for curriculum, please advise.
