All orders are now in compliance, though licensing staff is waiting to verify the above.</p> <p>The Operator purchased a Kitchen creation play doh set and assisted children with opening the packaging. Children examined all the pieces for this activity. Children had different ideas and starting building with the pieces with the play doh. They started creating a variety of different shapes and explored with pushing, manipulating, cutting, rolling the play doh with their hands. Operator was observed kneeling down at children eye level and interacting using playful language.
