The ratio is respected at the time of the inspection. All required documents are posted in a visible and prominent place in the facility. The child attendance records are complete and showing all absences. Easily accessible storage space for the personal belongings of each child in attendance is provided.

The QAM had a discussion with the administrator regarding a 2-year-old child occupying a space in the infant classroom. The Quality Assurance Monitor reminds the administrator that a transition plan must be sent to the department, when a child can't transition in the 2-year-old classroom. With that, the QAM will follow up with the operator to ensure the transition is complete.
