General Comments

A monitoring inspection was conducted today on the infant and preschool rooms on the license.

Eight new and current staff files were reviewed and verified complete with all required documentation. In the three infant rooms, the Inspector observed the children arriving back to the centre from a walk, outside

play in the play yard with their peers, diaper changing, handwashing, morning snack and preparing for nap/quiet time. Mandatory attendance records, incident logs and daily information sheets were reviewed during the inspection and verified complete.

In the infant rooms, the Inspector observed the children's learning was documented and displayed on the walks of the each of the three rooms. Pictures of the children engaged in sensory activities with pinecones, leaves, playing in the outside play area, playing dress up, reading books, sensory activities (sand/leaves), children exploring the Arts and Culture Park finding leaves, sticks, flowers, and painting with watercolors depicting the learning that is occurring. Educators have documented and displayed the children's learning on the walls of the rooms for the children and families to revisit. e

Inspector observed family pictures throughout each of the rooms as well as loose parts, toys, and books accessible to the children on low shelves.

In the three preschool rooms, the Inspector observed the children in the outside play area playing in the sensory table with water, transitioning to inside play, diaper changing, handwashing, lunch, nap/quiet time.

Children's learning is documented and displayed on the walls depicting the children's learning. Pictures of the children playing in the tuff trays with water and mini pumpkins, painting with pieces of pumpkins, Halloween sensory trays, exploring leaves, bubble wrap painting, playing with kinetic sand, tuff tray with construction trucks and loose parts, leaf rubbing, matching colors and pictures of bugs the children have found on their explorations with their educators.

Discussed with the Administrator diaper changing routines and recommending that this is reviewed with all staff to ensure that proper sanitizing and handwashing is occurring after each diaper change.

Educators were observed during the inspection down at the level of the children engaged with them in their learning and play, tending to their needs and using positive child guidance techniques when redirecting children.
