<p><b>General Comments</b></p> <p>Upon arrival in the morning, the QAM observed several groups of children engaged in outdoor activities. Some groups were on walks, while others were playing at a nearby playground equipped with swings, climbing structures, and slides.</p> <p>In the indoor learning environments, educators were preparing children to go outside. In the younger rooms, educators organized children into small groups and provided direct assistance with putting on outdoor clothing. In the older rooms, educators were present to offer support as needed, promoting independence.</p> <p>Children who remained indoors were observed engaging in activities such as puzzles, toy animals, and looking at books. All learning environments contained a wide range of materials to support literacy, dramatic play, construction, and art, providing children with varied and developmentally appropriate learning opportunities.</p> <p>A review of child ratios, the parent information board, and staff files indicated that all were accurate, complete, and up to date.</p>
