General Comments

- Visit to the learning center for an unexpected monitoring inspection
- Ratio was respected during the visit
- Each child has an easily accessible space for personal belongings, which is labeled with the name of the child and used only for the intended child.
- Toxic products, chemical products and cleaning supplies are locked and inaccessible to children
- Individual space is provided for diapers, creams and wipes for each child who is not toilet trained. The changing table is equipped with a safety strap and a non-absorbent layer. Changing area is separated from the food preparation and is located one meter or less from a sink. Children are always supervised during diaper changing.
- Center has the proper number of functioning and available toilets and sinks, one potty chair or training seat is provided, and a step or platforms are provided to allow children to reach regular sized toilets or sinks. During the visit one toilet is clogged, a plumber was called the proper amount of toilet is still available for the number of children on site.
- An inclusive environment is provided for all children
- Daily activities into the center shows purposely planned and documented programming that gives children, Time, and space for a free choice of play experiences, indoor and outdoor opportunities for physical activity either individually or in a group. Children have opportunities for various forms of literacy and to express creativity and interests, to explore the arts and sciences and to experience accomplishment and success. They have opportunities to problem solve and to develop trusting, respectful and supportive relationships.
- Children's guidance is done in a respectful and positive way
- Posted in a visible and prominent place in the facility are the following documents: The license, inspection report, orders for compliance, daily routine, evacuation procedures, name of administrator, name and telephone number of QA Monitor and Inspector Life-threatening allergies and a notice to inform parents of the existence of a communicable disease.
- Zones needs to be worked on in one of the rooms, materials are available for the children, but the amount needs to increase in the craft area.

Observations: When arriving at the center the infants and the fours were playing outside, the twos were playing with play doh and the threes were in free play. During the visit all children had their lunch and transitioned into
